Additional Information to Add to Report # 25-004987: Forgery of Public Records by the Staff of Danville Area Humane Society While Operating the City of Danville Public Animal Shelter – Reclaimed by Owner and Transferred Forgeries

Reclaimed by Owner Forgeries-2023

The staff of Danville Area Humane Society, Inc. (DAHS) while operating as Danville Animal Control and Public Animal Shelter, have purposefully forged public documents with the intent to deceive the Virginia Department of Agriculture and Consumer Services, The Virginia State Veterinarian, the City of Danville and the Commonwealth of Virginia. DAHS staff have routinely stated on public custody records for numerous animals in their care that said animals were “reclaimed by owner” when in fact, they were euthanized.

In 2023, DAHS reported to VDACS that a total number of 200 animals were reclaimed by owner (see Column J in Figure 1 below) yet their custody records, obtained via FOIA, only show 183 animals being reclaimed by owner in 2023.

Danville Area Humane Society staff purposefully submitted their required annual report to the Virginia Department of Agriculture and Consumer Services (VDACS) on 2/15/2024 stating that in 2023, 200 animals were reclaimed by their owners from the public shelter they manage, which is 17 animals more than what is found in their custody records. Again, only 183 custody records with a final disposition of “returned to owner” or RTO (reported to VDACS as reclaimed by owner) were found in the 2023 custody records provided in response to multiple FOIA requests.

Of the 200 animals with a final disposition of “returned to owner” on DAHS public custody records, 6 of those animals (highlighted in purple above and listed separately in the chart below) were **euthanized** according to evidence present in other public FOIA documents and records in 2023.

These 6 animals bring the deficit of 17 animals between the number of animals reported to VDACS as reclaimed by owner in 2023 (i.e. 200) and the custody records given to me that indicate a disposition of “returned to owner” (i.e. 183) up to 23. Considering that 6 of these records were forged by DAHS staff to indicate a disposition of “returned to owner” when there is contradictory evidence proving those animals were in fact euthanized, it is reasonable to ascertain that these 6 records and the missing 17 records were intentionally among the 200 reported to VDACS as “reclaimed by owner” in 2023.

Therefore, it is my assertion that the staff of Danville Area Humane Society, while operating as Danville Animal Control and Public Shelter, misrepresented the number of animals reclaimed by their owners from the public animal shelter they manage by more than 11% through the use of forgery and with the intention of deceiving VDACS, the Office of the State Veterinarian, the Danville community, Danville City Council and the Commonwealth of Virginia. I believe this forgery was committed intentionally to allow the staff of the city contractor, Danville Area Humane Society, Inc., to maintain their positions as managers of the City of Danville public animal shelter for which they receive approximately \$250,000 annually.

Evidence

The following pages are the copies of custody records, cage cards and euthanasia logs given to me by Danville Area Humane Society in response to numerous FOIA requests. Each piece of evidence has a cover page with the affected animal's custody record number, and the explanation of how the associated evidence proves that the animal's disposition was intentionally forged in writing on the public documents known as custody records, to indicate an erroneous final disposition outcome of transferred when it was obvious in their own subsequent records that the final disposition of said animal was euthanized.

Evidence of additional, continuing forgery as well as potential other crimes have been found in Danville Area Humane Society's 2023, 2024 and 2025 public records as well. I reserve the right to amend this report at any time to include more instances of forgery found in additional types of public records and documents created and/or controlled by DAHS. Transferred Forgeries-2023

The staff of Danville Area Humane Society, Inc. (DAHS) while operating as Danville Animal Control and Public Animal Shelter, have purposefully forged public documents with the intent to deceive the Virginia Department of Agriculture and Consumer Services, The Virginia State Veterinarian, the City of Danville and the Commonwealth of Virginia. DAHS staff have routinely stated on public custody records for animals in their care that said animals were “transferred” when in fact, they were euthanized.

In 2023, DAHS reported to VDACs that a total number of 138 animals were transferred (see Columns L and M in Figure 1 below) yet their custody records, obtained via FOIA, only show 130 animals being transferred in 2023.

Danville Area Humane Society staff purposefully submitted their required annual report to the Virginia Department of Agriculture and Consumer Services (VDACS) on 2/15/2024 stating that in 2023, 138 animals were transferred from the public shelter they manage, which is 8 animals more than what is found in their custody records. Again, only 130 custody records with a final disposition of “transferred” were found in the 2023 custody records provided in response to multiple FOIA requests.

Of the 130 animals with a final disposition of **transferred** on DAHS public custody records, 2 of those animals (highlighted in orange above and listed separately in the chart below) were **euthanized** according to evidence present in other public FOIA documents and records in 2023.

These 2 animals bring the deficit of 8 animals between the number of animals reported to VDACS as transferred in 2023 (i.e. 138) and the custody records given to me that indicate a disposition of transferred (i.e.130) up to 10. Considering that 2 of these records were forged by DAHS staff to indicate a disposition of transferred when there is contradictory evidence proving those animals were in fact euthanized, it is reasonable to ascertain that these 2 records and the missing 8 records were intentionally among the 138 reported to VDACS as transferred in 2023. **Therefore, it is my assertion that the staff of Danville Area Humane Society, while operating as Danville Animal Control and Public Shelter, misrepresented the number of animals transferred from the public animal shelter they manage by more than 5% through the use of forgery and with the intention of deceiving VDACS, the Office of the State Veterinarian, the Danville community, Danville City Council and the Commonwealth of Virginia. I believe this forgery was committed intentionally to allow the staff of the city contractor, Danville Area Humane Society, Inc., to maintain their positions as managers of the City of Danville public animal shelter for which they receive approximately \$250,000 annually.**

Evidence

The following pages are the copies of custody records, cage cards and euthanasia logs given to me by Danville Area Humane Society in response to numerous FOIA requests. Each piece of evidence has a cover page with the affected animal's custody record number, and the explanation of how the associated evidence proves that the animal's disposition was intentionally forged in writing on the public documents known as custody records, to indicate an erroneous final disposition outcome of transferred when it was obvious in their own subsequent records that the final disposition of said animal was euthanized.

Evidence of additional, continuing forgery as well as potential other crimes have been found in Danville Area Humane Society's 2023, 2024 and 2025 public records as well. I reserve the right to amend this report at any time to include more instances of forgery found in additional types of public records and documents created and/or controlled by DAHS. Page 3 is another copy of the Custody Record for animals 34423, 34424, 34425, 34426, 24437, 34428 and 34429, received on 8/18/2023. On this Custody Record, number 34426 is circled with "euth" written out beside it. At the bottom of the page, in the Disposition of Animal box, is the word "euth" and in the date box is the date of 8/23/2024, indicating that 34426 was euthanized on 8/23/2024, yet that's impossible since there is a euthanasia log from 8/23/2023 with the number and information matching 34426 on it.

Page 4 is two cage cards. The first cage card is for animal 34426 indicating that this animal was euthanized on 8/23/2024. The second cage card is for animal 34428, indicating this animal was euthanized on either 8/1/2023 or 9/1/2023.

Page 5 is a page from the DAHS euthanasia log with Custody Record 34426 highlighted on 8/23/2023, indicating the animal with this number was euthanized on 8/23/2023, NOT 8/23/2024.

If the mom and her 6 puppies were brought in as strays, and 4 of them were euthanized, that only leaves 3 puppies to be transferred – not 4.

Died While in Custody Forgeries-2023

The staff of Danville Area Humane Society, Inc. (DAHS) while operating as Danville Animal Control and Public Animal Shelter, have purposefully forged public documents with the intent to deceive the Virginia Department of Agriculture and Consumer Services, The Virginia State Veterinarian, the City of Danville and the Commonwealth of Virginia. DAHS staff have routinely stated on public custody records for animals in their care that said animals were “DOA” (i.e. died while custody) when in fact, they were euthanized.

In 2023, DAHS reported to VDACS that a total number of 5 animals died while in their care (see Column N in Figure 1 below) yet their custody records, obtained via FOIA, show 26 animals as being DOA in 2023.

Danville Area Humane Society staff purposefully submitted their required annual report to the Virginia Department of Agriculture and Consumer Services (VDACS) on 2/15/2024 stating that in 2023, 5 animals died while in the custody of the public shelter they manage, which is 21 animals less than what is found in their custody records. Again, 26 custody records with a final disposition of “DOA” (i.e. died while in their custody) were found in the 2023 custody records provided in response to multiple FOIA requests.

Of the 26 animals with a final disposition of **DOA** on DAHS public custody records, 3 of those animals (highlighted in blue above and listed separately in the chart below) were **euthanized** according to evidence present in other public FOIA documents and records in 2023.

These 3 animals bring the total number of animals NOT reported to VDACS as having died while in custody in 2023 to 18.

Therefore, it is my assertion that the staff of Danville Area Humane Society, while operating as Danville Animal Control and Public Shelter, misrepresented the number of animals that died while in the custody of the public animal shelter they manage by more than 27% through the use of forgery and with the intention of deceiving VDACS, the Office of the State Veterinarian, the Danville community, Danville City Council and the Commonwealth of Virginia. I believe this forgery was committed to intentionally mislead and foster a belief that this shelter provides a safe, healthy environment for the animals they are responsible for, to allow the staff of the city

contractor, Danville Area Humane Society, Inc., to maintain their positions as managers of the City of Danville public animal shelter for which they receive approximately \$250,000 annually.

Evidence

The following pages are the copies of custody records, cage cards and euthanasia logs given to me by Danville Area Humane Society in response to numerous FOIA requests. Each piece of evidence has a cover page with the affected animal's custody record number, and the explanation of how the associated evidence proves that the animal's disposition was intentionally forged in writing on the public documents known as custody records, to indicate an erroneous final disposition outcome of DOA when it was obvious in their own subsequent records that the final disposition of said animal was euthanized.

Evidence of additional, continuing forgery as well as potential other crimes have been found in Danville Area Humane Society's 2023, 2024 and 2025 public records as well. I reserve the right to amend this report at any time to include more instances of forgery found in additional types of public records and documents created and/or controlled by DAHS.
