Section 3: Nature of Complaint:

Continuation of Forgery of Public Records by the Staff of Danville Area Humane Society While Operating the City of Danville Public Animal Shelter in 2024

Previously, we reported to this agency that the staff of Danville Area Humane Society, Inc. (DAHS), while operating as Danville Animal Control and Public Animal Shelter, purposefully forged public records in 2023 with the intent to deceive the Virginia Department of Agriculture and Consumer Services (VDACS), The Virginia State Veterinarian, the City of Danville, and the Commonwealth of Virginia. The evidence contained herein will prove that DAHS staff continued to forge public records in 2024.

Virginia law § 18.2-168. Forging public records, etc. If any person forge a public record, or certificate, return, or attestation, of any public officer or public employee, in relation to any matter wherein such certificate, return, or attestation may be received as legal proof, or utter, or attempt to employ as true, such forged record, certificate, return, or attestation, knowing the same to be forged, he shall be guilty of a Class 4 felony.

Positive disposition outcomes for animals affect the ability for shelters to receive grants, monetary and supply donations, as well as the likelihood that an entity running a city or county animal shelter will continue to do so when the contract for those services are renewed or rebid. In 2024, DAHS staff stated on public custody records for numerous animals in their care that said animals had a final disposition of adopted, reclaimed by owner or transferred, all of which positively affect their “save rate” by lessening their euthanasia rate for the year; yet these records were forgeries. DAHS staff also reported the positive dispositions they forged in their annual report to VDACS in 2024 to make their euthanasia rate appear to have improved significantly from the previous year, which was 82%, before the forgeries found in 2023 made the euthanasia rate more than 85%. The necessity for DAHS to report less animals being euthanized and more animals leaving the shelter alive is crucial to negate public scrutiny, secure and retain funding from grants and donations, continue as beneficiary of a \$1.8 million dollar endowment, and remain under contract with the City of Danville for a minimum of \$400,000 in city funds annually for operating the shelter.

For reporting year 2024, DAHS reported that to VDACS that 987 animals left the shelter alive, by being reclaimed by their owner, adopted or transferred (see Figure 2 below, Columns J, K, L and M).

The custody records that were obtained from DAHS via FOIA, however, only show 839 animals leaving the shelter alive (see Figure 3 below). The deficit between the number of animals DAHS reported and the number of animals found in their records is an astounding 148 animals.

Reclaimed by Owner Forgeries-2024

Danville Area Humane Society staff purposefully submitted their required annual report to the Virginia Department of Agriculture and Consumer Services (VDACS) on 1/30/2025 stating that in 2024, 190 animals were returned to their owner by the staff of the public shelter they manage, which is 2 animals more than what is found in their custody records. Again, only 188 custody records with a final disposition of “Returned to Owner or (RTO)” were found in the 2024 custody records provided to us in response to multiple FOIA requests.

The custody record ID numbers of the 188 animals found in the DAHS custody records obtained via FOIA that had a final disposition of Returned to Owner (RTO) (reported as Reclaimed by Owner to VDACS) in 2024 are as follows:

Of the 188 animals with a final disposition of “**Returned to Owner (or RTO)**” on DAHS public custody records, 2 of those animals (highlighted in blue above and listed separately in the chart below) were **euthanized** according to evidence present in other public documents and records obtained by FOIA in 2024.

These 2 animals bring the deficit between the number of animals reported to VDACS as “**Reclaimed by Owner**” in 2024 (i.e. 190) and the custody records given to me which indicate a disposition of “**Returned to Owner**” (i.e. 188) up to 4. Considering that 2 of these records were forged by DAHS staff to indicate a disposition of returned to owner when there is contradictory evidence proving those animals were in fact euthanized, it is reasonable to ascertain that these 2 records and the missing 2 records were intentionally among the 190 reported to VDACS as “**Reclaimed by Owner**” in 2024.

Adopted Record Forgeries-2024

Danville Area Humane Society staff purposefully submitted their required annual report to the Virginia Department of Agriculture and Consumer Services (VDACS) on 1/30/2025 stating that in 2024, 251 animals were “Adopted” from the public shelter they manage, which is 46 animals more than what is found in their custody records. Again, only 205 custody records with a final disposition of “Adopted” were found in the 2024 custody records provided in response to multiple FOIA requests.

Of the 205 animals with a final disposition of “Adopted” on DAHS public custody records, 7 of those animals (highlighted in pink above and listed separately in the chart below) were **euthanized** according to evidence present in other public documents and records obtained by FOIA in 2024.

These 7 animals bring the deficit of 46 animals between the number of animals reported by DAHS as having been **“Adopted”** in 2024 (i.e. 251) and the custody records given to us that indicate a disposition of **“Adopted”** (i.e. 205) up to 53. Considering that 7 of these records were forged by DAHS staff to indicate a disposition of **“Adopted”** when there is contradictory evidence proving those animals were in fact **euthanized**, it is reasonable to ascertain that these 7 records and the missing 46 records were intentionally among the 251 reported to VDACS as **“Adopted”** in 2024.

Transferred Record Forgeries-2024

Danville Area Humane Society staff purposefully submitted their required annual report to the Virginia Department of Agriculture and Consumer Services (VDACS) on 1/30/2025 stating that in 2024, 546 animals were **“Transferred”** from the public shelter they manage, which is 100 animals more than what is found in their custody records. Again, only 446 custody records with a final disposition of **“Transferred”** were found in the 2024 custody records provided in response to multiple FOIA requests.

The custody record numbers of the 446 animals found in the DAHS custody records obtained via FOIA that had a final disposition of **“Transferred”** in 2024 are as follows:

These 12 animals bring the deficit of 100 animals between the number of animals reported to VDACS as **“Transferred”** in 2024 (i.e. 546) and the custody records given to us that indicate a disposition of **“Transferred”** (i.e. 446) up to 112. Considering that 12 of these records were forged by DAHS staff to indicate a disposition of **“Transferred”** when there is contradictory evidence proving those animals were in fact euthanized, it is reasonable to ascertain that these 12 records and the missing 100 records were intentionally among the 546 reported to VDACS as **“Transferred”** in 2024.

Conclusion

Our examination of the evidence supplied to us in response to FOIA requests prove that the staff of Danville Area Humane Society, while operating as Danville Animal Control and Public Shelter, misrepresented the number of animals reclaimed by owners, adopted or transferred from the public animal shelter they manage by more than 8.5% through the use of forgery and with the intention of deceiving VDACS, the Office of the State Veterinarian, the Danville community, Danville City Council and the Commonwealth of Virginia. We believe this forgery was committed intentionally to allow the staff of the city contractor, Danville Area Humane Society, Inc., to maintain their positions as managers of the City of Danville public animal shelter for which they receive approximately \$400,000 of city funds annually.

Evidence

The following pages are the copies of public records; custody records, cage cards and euthanasia logs given to us by Danville Area Humane Society in response to numerous FOIA requests. Each piece of evidence has a cover page with the affected animal’s custody record number, and the explanation of how the associated evidence proves that the animal’s disposition was intentionally forged, in writing, on public documents, to indicate an erroneous final disposition outcome of returned to owner, adopted, or transferred when it was obvious in their own subsequent records that the final disposition of said animals was euthanized.

Important Notes Regarding Evidence:

1. We requested ALL the public documents from Danville Area Humane Society, and these were the only ones we were “allowed” to have, and they came heavily redacted, which was

AGAINST the advice of the FOIA Council of Virginia. We have every email and correspondence with everyone, and any entity mentioned in this complaint should that correspondence be needed.

2. We implore you to not throw out the entirety of the record as being a forgery if the custody record number matches but some of the descriptions of the animals on the euthanasia logs do not match the animal descriptions on the custody records, and/or the weights indicated on the logs are completely wrong.
3. You can look at almost any custody record and corresponding cage card from when the animal came into the shelter and the weight listed on those two records is the same exact weight, days, weeks and even months later, when the animal is euthanized. Even though Danville Area Humane Society staff is supposed to be trained in euthanasia and should understand that it's imperative to weigh an animal before administering medication used to kill them, there are thousands of animals killed at DAHS that are the exact same weight the entire time they are there, and that weight seems to be nothing but a guess.
4. The euthanasia logs we received have 1,931 instances of an animal being euthanized. DAHS reported 2,213 animals euthanized in 2024, which is 282 more than what we have evidence of.

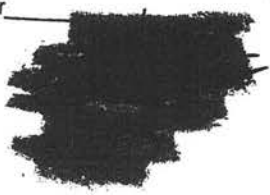

This custody record number aligns with all the others in this date range, whereas the custody record number above (38385) is an anomaly. The custody record numbers by date indicate that custody record 38385 above should have an intake date of 9/25/2024. This is just one example of the many times I have seen strange custody records for animals throughout the FOIA documents. I included this example because of the similarities in the description of the animal, discrepancy in the custody number of the forged record compared with the date and the other numbers for that day/week, and most importantly because a custody record that looks to be for the same animal was forged.

Page 1 is the Custody Record for animal 38834 received on 10/19/2024. At the bottom of the page, in the Disposition of Animal box, is the written "Adopted" and in the date box is the date of 10/28/2024, indicating 38834 was adopted on 10/28/2024.

To the right of the date box are three dates, which are supposed to indicate when the DAHS staff checked the animal for a microchip, which they are required to do at least once when they come in and again before the animal's final disposition. The third date, circled in red, is another forgery by itself. This procedure of writing the dates beside the disposition date was created after the first complaint was filed against DAHS with VDACS on 10/14/2024. In that complaint, I stated that there was no indication that animals were being checked for microchips, as required by law. The VDACS inspectors found that as well and issued a violation to DAHS - see the following excerpt from the VDACS Inspection of DAHS on 12/10/2024:

3.2-6585.1 Non-Critical Violation: There was not documentation of the two additional microchip scans (at assessment and prior to disposition) required for unidentified animals disposed within the previous 30 days. This includes dogs 39006, 39178, 39201, 39202, 39203, and 39204 disposed on 12/10/24 prior to the start of this inspection.

The following excerpt is the DAHS Director's response to the violation above in an email to VDACS Inspector Sherry Helsel on 12/20/2024:

3.2-6585.1

Non-Critical Violation

Incoming animals are scanned for a microchip upon intake. If one is found, the chip information is recorded on the intake; information about the registered owners is also recorded. If no chip is present, "None detected" is noted on the intake, as instructed by Office of Veterinary Services' staff.

The animals are scanned twice more as required. They are scanned one additional time while shelter staff interact with them (no specific requirement of when that takes place is stated in Code) and again before disposition.

We have not recorded the two additional times on the intake (custody) forms, but shelter staff have now been instructed to do so. We now have an established way of documenting the three scannings. This violation is strictly one of documentation, not a failure to check for chips.

Page 2 is a page from the DAHS euthanasia log with Custody Record 38834 highlighted on 10/22/2024, indicating the animal with this Custody Record number was euthanized on 10/22/2024.

How did DAHS staff check this animal for a microchip on 10/28/2024 when he was killed on 10/22/2024?

Note: The inspection documents from the 12/10/2024 VDACS inspection of DAHS are in my possession, in their entirety, and they are available to representatives of the Danville Police Department or any other law enforcement agency that requests them.

Explanation of Evidence:

Page 1 is the Custody Record for animals 38305, 38466, 38467, 38468 and 38469. Animal number 38305 is a pregnant cat that was received on 9/14/2024 and animals 38466, 38467, 38468, and 38469 are kittens that were born on 9/16/2024. This is another example of numbers being completely off compared to the dates they entered the shelter, as this would imply that over 161 animals were admitted to this shelter in 2 days. At the bottom of the page, in the Disposition of Animal box, is written “38305-Blk/White F – Momma Transfer” and in the date box is the date of 10/3/2024, indicating that Momma was transferred on 10/3/2024.

I highlighted the “microchip scan date” of 10/3/2024 and circled it in pink.

Page 2 is a page from the DAHS euthanasia log with Custody Record 38305 highlighted on 9/22/2024, indicating the animal with this Custody Record number was euthanized on 9/22/2024.

How did DAHS staff scan for a microchip on 10/3/2024 when this momma cat was killed on 9/22/2024?

Section 4: Resolution Attempted by Complainant

We have been contacting individuals associated with Danville Area Humane Society via social media for the last two years. We have also appeared before Danville City Council on separate occasions to speak about these issues and request their assistance. Most recently, we have reported DAHS staff to the local authorities for forging public documents in 2023 and 2024.

On 8/28/2025 a report of forgery of public records was filed with the Danville Police Department (DPD Report #25-004987) concerning DAHS staff forging public records in 2023 to state animals were adopted when in fact, they were euthanized.

On 10/9/2025, Report #25-004987 with the Danville Police Department was amended to include narrative and evidence of additional forgeries of public records in 2023 to state animals were reclaimed by their owner, transferred, or died while in custody when they were euthanized.

On 10/20/2025, Report #25-004987 with the Danville Police Department was amended to include narrative and evidence of additional forgeries of public records in 2024 to state animals were adopted, reclaimed by their owner, or transferred when they were euthanized.

We have also submitted 5 prior complaints with this agency:

Complaint #5 filed on 10/19/2025 regarding DAHS staff forging public records (i.e. 2023 custody records) to state animals were Returned to Owner, Transferred or DOA when they were euthanized.

Complaint #4 filed on 8/28/2025 regarding DAHS staff forging public records (i.e. 2023 custody records) to state animals were adopted when they were euthanized.

Complaint #3 filed on 8/15/2025 regarding DAHS not sedating animals prior to euthanasia in 2024

Complaint #2 filed on 8/13/2025 regarding DAHS not sedating animals prior to euthanasia in 2023

Complaint #1 filed on 10/14/2024 regarding Danville Area Humane Society, Inc. (DAHS) allegedly committing the following violations of the Code of Virginia in 2023:

- 423 separate instances of animals listed on custody records as stray, animals listed as stray with notes showing evidence of identification, and animals listed as being subject to a bite quarantine of 10 days, being euthanized prior to the hold period provided by § 3.2-6546 C. **[Found and resulted in a critical violation in VDACS inspection on 12/10/2024]**
- 2,200 custody records, representing 3,575 custody record numbers, with approximately 160 records missing and 754 records containing multiple animals in violation of § 3.2-6557 B.
- 217 custody records with errors involving intake dates, species descriptions, custody reasons, identification notes, and disposition dates in violation of § 3.2-6557 B.
- 24 records that had dispositions recorded on custody records as adopted, transferred or returned to owner appear in the euthanasia logs as having been euthanized, in violation of § 3.2-6557 B.
- 48 separate instances where it was noted that animals were sick, unweaned, and/or injured, yet were not euthanized for some period of time, indicating possible cruelty in violation of § 3.2-6566.
- 25 instances of animals being accepted by DAHS from other states without evidence of a health certificate in violation of 2VAC5-141-80 E.

- More than 1,700 animals were listed as stray on the DAHS custody records, yet less than 20 animals show evidence of being checked for a microchip, in violation of § 3.2-6585.1. **[Found and resulted in a non-critical violation in VDACS inspection on 12/10/2024]**
- Euthanasia of animals does not meet the written protocols established and approved by the State Veterinarian or the shelter's own supervising veterinarian in violation of § 54.1-3423 E. **[Found and resulted in a non-critical violation in VDACS inspection on 12/10/2024]**
- No evidence or documentation that certified shelter staff are administering the legally required sedative as detailed in the AC6 on file at the shelter and required to be recorded by 18VAC110-20-580 (6).
- The certificates for two of the three staff members that perform euthanasia at DAHS do not have the required box checked indicating that the supervising veterinarian believes they have demonstrated competency in understanding and applying State Veterinarian's Directive 79-1, Methods Prescribed or Approved for Animal Euthanasia, the absence of which invalidates their certification pursuant to 18VAC110-20-580 (2). **[Found and resulted in a non-critical violation in VDACS inspection on 12/10/2024]**
- There are a significant number of cases where the volume of euthanasia solution given was greater than the animal's weight in pounds. **[Found and resulted in a non-critical violation in VDACS inspection on 12/10/2024]**
- The euthanasia logs kept by DAHS do not meet the requirements of Virginia Administrative Code 18VAC110-20-580 (6). **[Found and resulted in a non-critical violation in VDACS inspection on 12/10/2024]**

This complaint indicated hundreds of potential violations cataloged in an excel spreadsheet accompanied by over 2,600 pages of evidence and was sent to this agency (VDACS), the Office of the State Veterinarian (Dr. Bissett), and the Virginia Board of Pharmacy.

As noted above, a routine inspection of Danville Area Humane Society by VDACS on December 10, 2024, **almost 2 months after** our complaint of the numerous and egregious potential violations with over 2,400 pages of evidence was received by this agency, found several of these violations to be valid while only looking at one week of documentation. Danville Area Humane Society was found guilty of several violations, including a critical violation that resulted in the deaths of four puppies prior to their hold period being met. Despite the numerous violations found in just a week's worth of DAHS paperwork and documentation, VDACS did nothing other than to write a report citing the violations and allow DAHS to lie their way out of the penalty. The following is an excerpt from the letter sent by H. Lane Songer, DVM, in response to his revocation of the fine associated with the critical violation:

“Although the penalty has been rescinded, Danville Area Humane Society Public Animal Shelter’s violation of § 3.2-6546, subsection C will remain on file. The Office of Veterinary Services Civil Penalty Matrix (Enclosure 3) provides for an escalating penalty assessment based on the number of repeat violations for the same factual basis within the preceding five calendar years. If your corrective action plan is not implemented and the same violation is cited in future inspections, the assessed civil penalty may be up to \$1,000.00 per day starting the date of your last inspection, December 10, 2024, and continuing until the date of your next inspection”.

As Dr. Songer stated in his letter rescinding the fine imposed on DAHS for violating the animal care laws of Virginia, the Office of Veterinary Services Civil Penalty Matrix *“provides for an escalating penalty assessment based on the number of repeat violations for the same factual basis within the*

preceding five calendar years” yet none of the evidence and proof of numerous violations we submitted to VDACS, the State Veterinarian or the Virginia Board of Pharmacy was acted upon. What is the purpose of a complaint process if the agencies with the power to inspect and act on public animal shelters that are violating state law do not do so; or more aptly pick and choose who they will use their law-given power on? Our previous complaint which contained the exact proof of nearly every violation Danville Area Humane Society has committed against the animals in their care and nearly all of which were found in ONE DAY of inspection by this agency.

Why is VDACS, the Office of Veterinary Services and the Virginia Department of Pharmacy letting Danville Area Humane Society off the hook, when every other shelter in Virginia must adhere to the animal care laws or face strict penalties and/or fines? For example:

Brunswick County Animal Shelter, January 2023

The State Office of Veterinary Services found multiple violations at the Lawrenceville shelter. Those violations included; animals not appropriately fed, the facility not kept clean, dry, and sanitary, adequate care not provided for seven dogs confined in the facility at the time of the inspection, animals euthanized in a manner that does not comply with methods established by the state veterinarian. “They did a very thorough, detailed inspection and found numerous, numerous deficiencies,” according to Brunswick County Supervisor John Zubrod.

Charlottesville-Albemarle County SPCA, February 2023

A Virginia Department of Agriculture inspection found repeated violations of state law at Charlottesville-Albemarle SPCA, including several documents at the shelter that were missing information required by state law. According to a February 15, 2023 article entitled “Who keeps watch over Virginia’s animal shelters?” on WVTF.org, the Department of Agriculture and Consumer Services employs two inspectors who spend a few hours, even a day reviewing shelter operations. They report to veterinarianCarolynn Bissett. “If we see violations then we’re going to inspect more frequently, but on average it’s about every 12-18 months.” In 2019 an inspector said CASPCA had no critical violations but did not have adequate procedures for deciding if dogs or cats needed veterinary treatment, for controlling contagious and infectious diseases and for managing sick animals. In 2021 the inspector accused CASPCA of poor record- keeping, but Bissett said violations of this kind usually result in a warning or small fine. “Fifty to \$100. They can go up to even \$1,000 per violation, but that can be per day, so if we have a really serious situation which we haven’t gotten into in my tenure here, those certainly could mount up.”

What constitutes a “really serious situation” in Dr. Bissett’s opinion? Thousands of violations in a year that were discovered by regular citizens and submitted to VDACS and all other agencies in a spreadsheet with over 2,400 pages of evidence to prove them and perpetrated by the highest kill shelter in the state of Virginia and the United States for animal shelters that take in more than 2,000 animals a year...would that be considered a “really serious situation”?

As constituents of the Commonwealth of Virginia, we expect the evidence contained in this complaint and any subsequent complaints brought to the attention of your agency and all others tasked with “inspecting public animal shelters for the purposes of determining if a violation of any state law governing the care, control or protection of animals” to be treated as such. We expect swift and immediate action concerning the unlawful acts being committed by our city’s public animal

shelter, Danville Area Humane Society, which we have once again brought to your attention, and we do so on behalf of the companion animals that continue to suffer and die at the hands of the animal shelter staff that **by statute** must protect them. Any action less than the most severe afforded to an agency tasked with upholding the animal care laws of the Commonwealth is evidence of corruption, incompetence, and engagement of collusion by VDACS and the Office of the State Veterinarian.

We have made multiple requests of your agency to do your duty to protect these animals. The laws are clear and your agency has been given every chance to rectify these issues by coming to this shelter and performing an unbiased, all-encompassing, in-depth inspection for more than an hour to discover the facts behind the outlier, extreme and unbelievably high euthansia rates at this one particular shelter in the Commonwealth. Your personal beliefs and friendships should have absolutely no impact on any inspection-ever.

Let there be no misunderstanding: when your inspectors willfully disregarded their statutory obligations and abdicated their duty of care to safeguard Virginia's companion animals - effectively discarding those responsibilities into the same dumpster behind Danville Area Humane Society that contains thousands of bags of lifeless bodies every year - they engaged in conduct amounting to gross negligence and a breach of public trust. Every subsequent death is not incidental; it was the foreseeable and direct consequence of your agency's failure to act.
